



ELECTION 2014- 2015

Subject: 1st Annual General Meeting & Election of The Members of Managing Committee for the year 2014 – 2015

Respected Member,

Pursuant to the Memorandum and Articles of Association of Pakistan Afghanistan Joint Chamber of Commerce & Industry – PAJCCI, Election for the year 2014 – 2015 is being announced and nominations are hereby invited from interested eligible members of PAJCCI, desiring to stand for election of Members of Managing Committee.

Election Commission

The Election Commission for holding elections of PAJCCI shall comprise the following persons:

Returning Officer – Mr. Talat Mahmood

Scrutinizer – Mr. M. Jawed Bilwani

Polling Officer – Mr. M. Saqib

Eligibility to Vote

As per Memorandum & Articles of Association of PAJCCI and subject to provisions of Section-15 of the Trade Organization Ordinance 2013, the eligibility of a member of PAJCCI to vote at the election shall be subject to following conditions:

- a) The member has completed two years of valid membership of PAJCCI as on the date of announcement of election schedule.
- b) The member has fulfilled the conditions of membership and renewal thereof under Rule 11(5) of the Trade Organizations Rules-2013.

Every member eligible to vote shall deposit with the Secretary General, the specimen card along with photograph indicating the status in the firm, company or concern. The right to vote shall be allowed only to the Proprietor, Partner or Director of the member firm or company, or a person not below the rank of General Manager authorized by the Board of Directors of a public limited company or multi-national corporation, as the case may be.

The Proprietor, Partner or Director of the member firm or company, concern or a person not below the rank of General Manager authorized by the Board of Directors of public limited company or a multi-national company shall be entitled to cast vote at the time of election only if name of such person has been registered with the Secretary General and his name appears on the list of voters.

Seats of Managing Committee

Elections shall be held to fill the following 6 seats in the same ratio i.e. 2:2:2 each from Karachi, Chaman and Peshawar:

Nominations

1. Every member having no outstanding dues in the Chamber is entitled for Nominations to contest the election
2. Nomination paper should be enclosed in a plain and sealed envelope.
3. Nomination papers are available with the office of the Chamber and can be obtained during office hours on the dates mentioned in the schedule.

Within the period mentioned in the Election Schedule of the issuance of the final voters any person who is eligible to contest the election for the vacant post, shall send his nomination duly proposed, seconded and signed by the candidate to the secretary on the prescribed form in accordance with the Articles of Association.

Fees

Election fees of Rs. 2500 shall be paid along with the nomination form. Pay order of Rs. 2500 on the name of Pak Afghan Joint Chamber CI can be sent to along with the filled nomination form.
